**ELIGIBILITY:** The Lōkahi FCU 89<sup>th</sup> Annual Membership Appreciation Prize Drawing (the "Drawing") is open to all members of Lōkahi FCU who are at least 18 years of age at the time of entry. Proof of age, identity, and eligibility may be requested by Lōkahi FCU. Employees, officials, and representatives of Lōkahi FCU, their immediate family members, and members of the same household are not eligible to enter or win in this Drawing.

**PROMOTIONAL PERIOD:** All entries must be received between 12:00:00 a.m. Hawaiian Standard Time (HST) January 5, 2026 and 11:59:59 p.m. HST March 6, 2026 (the "Promotional Period").

**HOW TO ENTER:** There are two (2) ways to enter the Drawing during the Promotional Period:

- 1) Submit an online entry at [www.lokahifcu.com/memberdrawing](http://www.lokahifcu.com/memberdrawing); or
- 2) To enter without purchase or credit union transaction – You may enter the Drawing via U.S. mail by legibly printing in black ink, "Lōkahi FCU 89<sup>th</sup> Annual Membership Appreciation Prize Drawing," followed by your full name, address, city, state, ZIP code, and daytime telephone number (including area code) on a 3" x 5" card, and mailing it in a #10 envelope with correct postage affixed, to: Attn: Marketing Department; Lōkahi Federal Credit Union; P. O. Box 30025, Honolulu, HI 96820. Mail-in entries for the drawing must be received during the Promotional Period in order to be eligible. Lōkahi FCU is not responsible for stolen, lost, late, misdirected, delayed, damaged, inaccurate, incomplete, illegible, undelivered, or postage-due mail.

**ENTRY CONDITIONS:** Limit one entry per person, regardless of entry method.

**PRIZE DETAILS:** One (1) prize of \$1,500 cash; three (3) prizes of \$750 cash; three (3) prizes of \$500 cash; three (3) prizes of \$250 cash; and twenty-nine (29) prizes of \$100 cash. Prizes awarded "as is" with no changes or substitutions.

**DRAWING:** Thirty-nine (39) winners will be determined in a random drawing from among all eligible entries received during the Promotional Period. The random drawing will be held within ten (10) days after the Promotional Period ends. By entering the Sweepstakes, you are expressly authorizing Lōkahi FCU and its employees and agents to contact you at the telephone number and/or mailing address you provided for the express purpose of notifying you should you be a winner. The winners will be notified via telephone and/or mail within 3-5 days from the drawing. Winners must respond and claim prize within five (5) business days or will be subject to disqualification, in which case the Prize will be forfeited, and an alternate Winner will be selected from the remaining eligible entries by random drawing.

**ODDS:** Actual odds of winning depends on the number of eligible entries received during the Promotional Period. Based upon an estimated 5,000 entries, odds of winning are 1:5,000.

**LIMITATION OF LIABILITY:** Winners and entrants agree to release, discharge, indemnify and hold harmless Lōkahi FCU and each of their respective officers, directors, employees, representatives and agents from and against any claims made by the winner, entrants or any other third parties related in any way to the operation of this Drawing, as well as any other claims, damages or liability due to any injuries, damages or losses (whether alleged, threatened, or actual) to any person (including loss of life) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance possession, misuse or use of any prize or participation in any giveaway-related activity or participation in this drawing. Entrants/winners hereby waive any objection to such exclusive jurisdiction and that such courts represent an inconvenience forum.
